## JOINT INDUSTRY STATEMENT ON WEEE SCOPE

The Trade Associations COCIR, DIGITALEUROPE, ELC and TechAmerica Europe call on the representatives of the Member States in the Council to reconsider the current proposal of reducing the number of product categories within the scope of the WEEE Directive. We strongly support maintaining the 10 categories from the current WEEE Directive.

We support the objective of the WEEE Recast to reduce the administrative burden and improve the legislative operational fit. Reducing the categories of the WEEE Directive would create a massive administrative burden, and would be a barrier to innovation as advances in recycling technology could change the required collection groups in order to optimize recycling and provide purer recyclates.

## A 5 category scope will create a massive administrative burden with no obvious benefits.

- Producers will have to verify products according to their length, height and width or their weight.
- All producers will have to adapt their reporting on products put on the market changing their IT and accounting systems.
- Some producers will have to report their products in more categories than before.

This increase in administrative burden is in direct conflict with the objectives of the WEEE Recast.

# A 5 category scope is not enough flexible to match with constant evolution in recycling technology.

- Advances in recycling technologies could change the required collection groups in order to optimize recycling and provide purer recyclates.
- It is vital that the collection groups can adapt to future changes.
- Waste streams need to be organised in such a way that they can be adapted according to the conditions in material value and scarcity as well as recycling technology.

## Producers favour retaining a 10 category scope because:

- It is a well-established and working system, deployed since 2005 in all EU countries.
- It will ensure consistency with the RoHS Directive and minimise the need for further discussions on exemptions, definitions and guidance.
- It will avoid the disruption of Member States' registration systems.



Industry jointly urges the Council to seriously consider the potential consequences that will affect not only industry but also organizations/authorities at local level in case the 5 category approach is preferred to the already well-established 10 categories one.
